

- 5. Managing employment and procurement expectations during «Skouries» construction and beyond.





Main topics (indicatively):

The inconvenience by heavy vehicles pass through the communities of Paleochori and Neochori was reported and discussed. It was confirmed that all the prescribed measures have been taken (such as speed limits) but also additional actions such as planning alternative routes etc. In addition to the prescribed measures, the Company plans to undertake the provision and operation of a sweeper to deal with dust on the road network.

Actions in progress:

Continuous waste rock monitoring from the underground development for the segregation of inert and non-inert material, in order to use inert rock as construction material.

Ongoing transfer of old tailings from the area of Olympias area to the TMF at Kokkinolakkas: 48,782 tons within the Q3 of 2024.

Transfer of 10,103 tons of topsoil hauled from Madem Lakkos to old Olympias TMF to be used for remediation.

Continued removal of pyrite and contaminated soils from the area of Stoa +53 to the TMF at Kokkinolakkas: 19,899 tons within the Q3 of 2024.

Pre-construction searches for flora and fauna took place in new areas for loggings (Karatzas Lakkos dam and road to dam 2, water collection pond No. 2 - embankment, diversion fresh-water channel - KT2, filter plant and U/G fan). There was not any critical finding.
