



- Discussion about traffic congestion and transport-related risks, as well as measures to mitigate them, with a parallel presentation of the reporting mechanism.





### Key issues raised include:


The issue of dust and noise caused by heavy vehicles passing through the communities of Paleohori and Neohori.

### 6. Environment

# During the reporting period (Q1 2024):

- A decision was issued by the Central Archaeological Council, followed by a decision of the Ministry of Culture, concerning the siting of the filter presses and primary crushing unit at the Skouries project.
- On 22.1.2024 the Ministry of the Environment and Energy approved the technical memorandum on non-material changes in the environmental impacts of the Skouries project.

#### **Actions under way:**

Ongoing process of separating aggregates and non-aggregates for use in construction work at the worksite.



Old tailings continue to be transported from the Olympias area to the modern dry stacking area at Kokkinolakkas 64,375 tons transported during Q1 2024

Continued transport of contaminated soils from the area of the tunnel at +53 to the modern Kokkinolakkas Disposal Facility: 20,567 tons transported within Q1 2024. Transport of 4,302 tons of sound soil to cover the site after remediation.



The +360 site at Madem Lakkos and the old waste rock deposition area at Firé stacking area at Olympias were sown with 3,282 grids and planted with 1,221 plants to regenerate those areas with local flora species.



An active nest for the species *Cyanistes caeruleus* was identified during biodiversity protection surveys at the Skouries logging sites. Logging in the wider area of the nest has been banned until the nest is abandoned.
